THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3406z. (1) Subject to subsection (3), an insurer that
- 2 delivers, issues for delivery, or renews in this state a health
- 3 insurance policy shall provide coverage for hearing aids for the
- 4 treatment of hearing loss for a qualified enrollee that are
- 5 selected by an audiologist after evaluation of the enrollee. The

- 1 maximum required coverage under this subsection is \$3,000.00 per
- 2 hearing aid every 36 months.
- 3 (2) A qualified enrollee may choose to purchase a hearing aid
- 4 that exceeds the maximum required coverage amount under subsection
- 5 (1). If a qualified enrollee chooses to purchase a hearing aid that
- 6 exceeds the maximum required coverage amount, the qualified
- 7 enrollee is responsible for the difference.
- 8 (3) An insurer may subject coverage under this section to the
- 9 deductibles and coinsurance of the health insurance policy.
- 10 (4) As used in this section:
- 11 (a) "Audiologist" means that term as defined in section 16801

- 13 (b) "Hearing aid" means a wearable, nondisposable instrument

- 15 designed or offered to aid or compensate impaired human hearing.
- 16 (c) "Physician" means either of the following:
- 17 (i) A physician licensed to engage in the practice of medicine
- 18 under part 170 of the public health code, 1978 PA 368, MCL
- 19 333.17001 to 333.17097.
- 20 (ii) A physician licensed to engage in the practice of
- 21 osteopathic medicine and surgery under part 175 of the public
- 22 health code, 1978 PA 368, MCL 333.17501 to 333.17556.
- (d) "Qualified enrollee" means an enrollee to whom both of the
- 24 following apply:
- (i) A physician has medically evaluated the enrollee, has
- 26 determined that the enrollee is a candidate for a hearing aid, and
- 27 has referred the enrollee to an audiologist for evaluation,
- 28 selection, and fitting.
- 29 (ii) The enrollee is less than 19 years of age.

Enacting section 1. This amendatory act applies to health
insurance policies delivered, executed, issued, amended, adjusted,
or renewed in this state, or outside of this state if covering
residents of this state, beginning 180 days after the date this
amendatory act is enacted into law.

Enacting section 2. This amendatory act does not take effect
unless Senate Bill No.____ or House Bill No.____ (request no.

03390'23) of the 102nd Legislature is enacted into law.
